Goals 1,9,10 and 17 greatly inform developmental mission of Micro- Small and Medium Enterprises in AfCFTA driven industrialization and transformation of marginalized communities in Zimbabwe, Southern and Sub Saharan Africa in a fourth industrial digital revolution phase (4IR). Indeed Micro-Small- Medium Scale Enterprises (MSMEs) drive for the AfCETA while finding resonance in the Davos 24 January new growth model, and a selected UNSDGs it practically inherits an integration and cooperation drive within a context of the Africa Agenda 2063, Aspiration 7 which situates Africa as a strong, united, resilient and influential global player and partner and also Aspiration 6 which advocates for an Africa, whose development is people-driven, relying on the potential of African people, especially its women and youth, and caring for children. The 2023 Africa Economic Outlook indicated hurdles for Micro-Small and Medium scale enterprises (MSMEs) for most economies within the sub Saharan Africa in the wake of potentially disruptive geopolitical tensions namely: Xenophobia in South Africa; Cape Delgado Mozambique Crisis; Foreign backed Coups in Sahel Region; outposts of dietatorship across regions of the world; Russia – Ukraine Crisis; Declining Culture of Human entric Constructive Dialogue; Superpower Nuclear Attack Threat; Middle East /Israel – Gaza Conflict and Superpower Pacific Rim tensions. These circumstances if not well tamed and reacted to, have a potential to compromise the Micro-Small and Medium Enterprises driven AfCFTA industrialization agenda in Zimbabwe, Southern, Sub Saharan Africa on a short, medium and long term. The 2023 Africa Economic Outlook report while alerting on hurdles confronting Microsmall and Medium scale enterprises (MSMEs) in most sub Saharan African economies proposed mitigatory and recovery policy priorities for responsive and progressive Member States toaddress namely: reducing rising inflation; managing exchange pressures; managing debtoobligations while creating space for development spending; and improving living standards and potential growth, particularly in resource intensive countries. Certainly, much to the favor of a responsive Zimbabwe, Southern and Sub Saharan Africa, the generational and transformative essence of Micro-Small and Medium Scale enterprises (MSMEs) driven AfCFTA mitiative as an immense legacy reclamation African Union flagship program is inevitable in this opportunity bound fourth industrial revolution phase.
